Registration Data

Spotify has access to information about you, which we collect in order to determine your eligibility for using Spotify, and to create and manage your account. This includes information you submit to us when you sign up for Spotify, such as email address, gender, date of birth, country of residence, username and date and time of sign up, as well as some additional technical data. If you signed up using your Facebook credentials or later connected your account to your Facebook account, we may also have information publicly available through your Facebook profile such as picture, Facebook username, friend list, networks etc. In particular, we have the following information:

Usage Data

When you use Spotify or products or services available through Spotify, we also collect some additional information about your use, such as:

- The playlists you have added to your profile
- Your playlist history, i.e. actions you have undertaken with your playlists
- The playlists you have made public
- The tracks you have “starred”
- Your notifications settings
- Your correspondence with Spotify Customer Service
- The devices you have used
- Your offline devices
- Your latest active session

We also keep logs of your activity on the Spotify service, including but not limited to data pertaining to the content you listen to (e.g. the songs streamed from your account) as well as certain other data, such as date and time, gender and birth date, IP address, operating system, browser type, device type, language and the version of Spotify that you are using.

Please see Attachment 1 to this letter for such activity logs, reflecting the content you have listened to on the Spotify service in the three (3) months prior to the date of your request and related information. Please let us know if you wish to access such activity logs for any other period of time.

Purpose of processing the data

We use your information as described in our Privacy Policy. This primarily includes to provide you with the services you have requested, to personalize and improve your experience, to communicate with you, including to send you information about our services and product, to ensure technical functioning, analyze use of the service

and to develop new services, and to enforce the agreement we have with you including to protect copyright material.

Sharing of data

We might share some of the above information with other companies within the Spotify group, with our business partners (for example Facebook, if you choose to integrate you Spotify account with your Facebook account) and with our service providers, such as companies assisting us in processing payments and maintaining our technical platform.

As described in our Privacy Policy, we provide you with settings to allow you to choose which communications you receive from us, manage your public profile information and set your sharing preferences for certain categories of data.
